# CRISM environmental scan: Naloxone distribution across Canadian provinces and territories

In response to an epidemic of opioid overdose deaths in Canada, distribution of the opioid antagonist naloxone has been identified as a key emergency measure to effectively prevent rising mortality. As a result, the programs aimed to distribute publicly-funded naloxone kits have been launched across the country.

Between January and May 2019, CRISM developed an environmental scan to consolidate information regarding current practices and programs aimed to distribute naloxone for use in suspected opioid overdose in Canada. The environmental scan process reviewed available grey literature and used interviews with key informants to better understand access and distribution of naloxone across Canadian jurisdictions.

Released in June 2019, the scan finds that over 590,000 publicly-funded naloxone kits have been distributed across more than 8,700 distribution sites in Canada. More than 61,000 kits have been reported used to reverse an overdose. Currently, all provinces and territories maintain publicly funded take-home naloxone programs. While access to naloxone has increased across the country, there remain important barriers to achieving equitable access across communities.

Pre-Announcement: Cannabis Research - Veterans' Health Pool



Veterans Affairs Canada (VAC) will partner with CIHR to fund the Veterans' Health Pool for this funding opportunity.

Ine purpose of the current <u>leam Grant</u> is to explore in more detail the potential therapeutic benefits and harms associated with cannabis use in a number of targeted areas identified through previous consultations. In particular, these Team Grants will address stakeholder priorities by supporting specific defined priority areas in targeted pools, to strengthen the evidence base and to build cannabis-related research capacity.

Veterans Affairs Canada's (VAC) mandate is to support the well-being of Veterans and their families. Using the determinants of health, VAC has developed a Veteran-specific well-being framework. VAC's objective is to fund research that will create evidence to inform policy related to cannabis use for medical purposes. VAC's current cannabis policy is available <a href="here">here</a>.

#### New Research Area - Veterans' Health Pool


Research into the impact of chronic cannabis use for medical purposes on Veteran health and determinants of health, including social determinants of health. Applications that involve clinical, health services and/or policy research approaches will be considered in this pool. In addition, VAC maintains administrative data for approximately 10,000 Veterans in receipt of cannabis for medical purposes. VAC may work with applicants to make use of this administrative data where possible and/or assist with Veteran recruitment.

#### **Funds Available**

\$3 million is available to fund two (2) applications relevant to the Veterans' Health Pool (sponsored by Veterans Affairs Canada).
