- 4. You can mix and match these menus to make your search more specific.

You can also search by:

Opportunity to contribute to development of a core outcome set for substance use



The International Consortium for Health Outcomes Measurement (ICHOM) is an independent not-for-profit organisation. Their mission is to support improvements in the quality of health and support services by encouraging providers to measure the treatment outcomes most important to people who access services.

ICHOM brought together an international Working Group including healthcare professionals, researchers, and those with lived experience with substance use disorders. Following a consensus-building process this group has suggested a core set of measures to assess a wide range of treatment outcomes. They are now seeking feedback on these measures from *professionals* in the field to improve this recommendation, which they hope will be a minimum global standard in clinical practice. A survey for Families/People with Lived Experience will be released soon.

Video: A PAWSitive Support Project for Veterans with PTSD and Who Problematically Use Substances

Learning how psychiatric service dogs can help veterans living with post-traumatic stress disorder (PTSD) recover from problematic alcohol and drug use is the focus of a new \$1.4-million research program led by Dr. Colleen Dell, titled A PAWSitive Support Project for Veterans with PTSD and Who Problematically Use Substances.

Working with participating service dog organizations, the goal of the team's three-and-a-half year project is to develop an addictions specific toolkit and pilot test it with 30 veterans from the AUDEAMUS service dog program. The kit will highlight the role of peer support, recognizing it is an important part of the Canadian Armed Forces culture, as well as addictions recovery.

Catalyst Grant: Cannabis and Mental Health



In October 2018, Canada became just the second country in the world to legalize cannabis for non-medical use. Legalization has provided for a much-needed opportunity to better understand the

the Mental Health Commission of Canada (MHCC) to help assess the impact of cannabis use on the mental health of Canadians. This investment will help inform future policy development, building on earlier significant public education investments of \$46 million that have helped inform Canadians.

There are pronounced gaps in knowledge concerning the negative impacts of cannabis use on mental health outcomes, the potential therapeutic benefits of cannabis and cannabinoids, the influence of mental health problems and illnesses on patterns of cannabis use, and the experiences and needs of diverse populations who live with cannabis use disorder and/or a mental illness.

The purpose of this current funding opportunity is to strengthen the evidence base and expand cannabis research related to mental health, to build cannabis-related research capacity and/or to inform the development of future larger-scale research projects. Lived experience perspectives will be meaningfully included in all stages of research, including research design, execution, knowledge translation and dissemination, and evaluation.

Excerpt:

"The growing chorus of voices now calling for drug policy change is encouraging. However, the underlying reasons for a new policy direction are critically important and, on that, many well-intentioned newcomers to the chorus are somewhat off key. The central cause for drug law reform is not its relevance to health or the present public health catastrophe. It is a matter of correcting a social injustice. Failing to articulate this in public discourse risks perpetuating harms on the people decriminalization advocates wish to help."

A new publication titled "Voices of Remanded Women in Western Canada: A qualitative analysis" by CRISM Prairies affiliated researchers is now available online.

"Based on 39 qualitative in-depth interviews conducted with remanded women in a Western Canadian remand prison as part of the University of Alberta Prison Project (UAPP), this article serves to describe the five main issues that women in our sample highlighted about their incarceration and how those were shaped by their own backgrounds and life histories: 1) Victimization; 2) Distrust of the police, 3) Parenting while incarcerated; 4) Addictions and mental health; 5) Contextual benefits of prison. The implications of this work for criminal justice practitioners, policymakers, and scholars are discussed."

Developmental Pathways of Addiction and Mental Health is sharing "Health Provider's Practice Modules" a Web-based interactive e-Learning curriculum to support service providers to enhance their practice.

The focus of these modules is to help health providers recognize and reduce significant stressors for vulnerable children and their parents, enhance their resilience, and increase their coping skills. In providing mental health support to children and youth the focus needs to shift toward health promotion and disease prevention, rather than just treating the impact of mental health disorders.

The Developmental Pathways of Addiction and Mental Health curriculum consists of eleven (11) modules, which were developed within a framework of four key learning areas:

- Enhancing foundational knowledge
- Promoting positive behaviour while enhancing relationship
- Promoting healthy development
- Advancing practice

Each module is approximately two hours in length and developed according to adult learning principles. The 11 modules are interactive, experiential, self-directed with a variety of reflective quizzes, case studies, self-assessments and videos.



CRISM environmental scan: Naloxone distribution across Canadian provinces and territories

In response to an epidemic of opioid overdose deaths in Canada, distribution of the opioid antagonist naloxone has been identified as a key emergency measure to effectively prevent rising mortality. As a result, the programs aimed to distribute publicly-funded naloxone kits have been launched across the country.

Between January and May 2019, CRISM developed an environmental scan to consolidate information regarding current practices and programs aimed to distribute naloxone for use in suspected opioid overdose in Canada. The environmental scan process reviewed available grey literature and used interviews with key informants to better understand access and distribution of naloxone across Canadian jurisdictions.

Released in June 2019, the scan finds that over 590,000 publicly-funded naloxone kits have been distributed across more than 8,700 distribution sites in Canada. More than 61,000 kits have been reported used to reverse an overdose. Currently, all provinces and territories maintain publicly funded take-home naloxone programs. While access to naloxone has increased across the country, there remain important barriers to achieving equitable access across communities.
